3 = The person is lost to follow up; cannot be located by People Finder, telephone, or by mail.

5 = The person is incarcerated.

6 = The person is in a nursing home or other medical institution.

7 = The person is very sick.

8 = The person does not comply.

9 = The person is otherwise difficult to deal with.

11 = The patient has withdrawn consent for us to speak with him.

12 = Based on past conversations with this person, we knew the answer would be "no."

13 = We knew that this patient was no longer capable of consenting.

4. a. The patient was asked and said "no" primarily because Reason - NO
- 1 = The patient is burned out on coming to routine research visits.
 - 2 = The patient does not want to be in a research study.
 - 3 = The patient is unhappy with the location of the place where the visits would be held (distance from home, parking, stairs, other conditions related to clinic) or has transportation problems.
 - 4 = The patient is unhappy with the AASK Study team members.
 - 5 = The patient is unhappy with the results of the AASK Study.
 - 6 = The person feels AASK causes problems with needing to get off work.
 - 7 = The person feels AASK causes problems with spending too much time away from family.
 - 8 = The patient feels that the AASK procedures are causing problems with the care from the primary care physician.
 - 9 = Care taker or family does not want the patient to enroll.
 - 10 = Patient has moved out of the country.
 - 11 = Patient blames the study for other medical conditions.
 - 12 = Patient feels they are too sick to enroll.
