DPPOS Data Archive

The Diabetes Prevention Program Outcome Study (DPPOS) is the long-term follow-up of the original DPP cohort. This report describes the public release of Phase 1 and Phase 2 of the DPPOS dataset. Phase 1 is based on all DPPOS data collected after the final DPP Bridge visits in 2002 and prior to the Phase 1 data lock in August, 2008. Phase 2 is based on all DPPOS data collected after the DPPOS Phase 1 data lock in 2008 and prior to the Phase 2 data lock in January 2014.

This DPPOS Archive contains the study summary, protocol, study data, forms, and dataset integrity check.

In addition, this data archive contains the bridge period, which was the time period following the main DPP (Diabetes Prevention Program) trial beginning in August 2001 and ending with the start of the DPPOS. This DPP bridge period dataset is based on all data collected after the main DPP visits ended in July 2001 and prior to the DPPOS Phase 1 period which started in the fall of 2002.
